### Views on the News Item :-

The State Govt. has noticed the news appearing in the Dainik Sambad dated 28th April'2006 titled as “**JAL BIDYUTHIN RAJYER MANUSH TEKKA DICHYA GAR AYEE**”. The news published did not reflect the actual economic situation of the State. The comments of the State Govt. on the said news are as follows :

- (i) The State Directorate of Economic & Statistics has been publishing the estimate of State Domestic Product (SDP) as well as per capita income over last three and half decades after discussion as well as following the guidelines of the C.S.O like other States and UTs. In 2003-04 the SDP as well as per capita income estimates has clearly increased with 1993-94 base .
- (ii) The SDP, per capita income and their growth published by the State Directorate of Economics & Statistics are less than similar figures prepared by the C.S.O. for Tripura. A comparative picture of the per capita income is as follows :

- (iii) All India per capita income is the average of economically advanced states and economically backward states. Therefore, per capita income of Tripura nearing the all India figure does not mean that the economic condition of the state has become close to the economic condition of the advanced states of the country, as alleged in the news item.
- (iv) Figures of the BPL as appearing in the news related to 1997. Although, the BPL survey, 2003 has been conducted but the result could not be finalised due to disagreement with Central Government on the methodology. There is no dispute on the fact that income has risen over the last ten years.

- (v) The published figures for safe drinking water and power services were also not correct.

The correct figures would be as follows :

Perspective plan for Agriculture for the years 2000-2010 as been taken up for development of agricultural sector. Some salient points are as follows :
